*Late Fees and Interest. If* payment is not received within 30 (thirty) days of the date specified on an invoice ("Past Due Date"), the account and payment are considered late and a late fee of thirty dollars (**\$30.00**) will be assessed to the Owner's account. Any assessments and late fees that remain unpaid as of the Past Due Date shall bear interest from and after the Due Date at the rate specified in Section 608 of the MOHA Covenants.<sup>2</sup>
