# Proposed Improvement Projects - Steve Carmichall



- Fence Replacement on BBD and NRR
  - Deteriorating condition of current fence
  - Budget for project to begin in 2019

#### > Mailbox and Post replacement

- Security Concerns
- Identity Theft
- Cost of replacements of current style post \$500-\$600
- Mail Manager 7506
- 22 mailboxes replaced in 2018; cost \$6416
- ➢ 46 mailboxes remain to be replaced; approx. \$15,000

#### > Drainage Repair on upper BBD

- > Water runoff impacting homeowner
- > Approx. cost for repairs is \$58,000

# Architectural Control for 2018 Vince DeSandro

#### Maintenance

- Snow removal –The snow removal call is 2" to be placed in the Queue.
- > Our new snow removal service is C. Martinez Landscaping.
- For snow removal on side streets, call Colorado Springs City Street Division and ask them to send a plow truck. The number is 719-385-5934. Request that anti-skid salt be put down at icy stop signs. For after hours requests (after 5 pm) call the emergency snow removal line at 719-278-8352. We will receive higher priority if there are more calls.

# 2018 Financial Summary Jill Mohler update



#### How did we spend the dues this year?

- Common Area Maintenance \$4,240 (spring clean up, summer weed removal, hail storm clean up, tree/stump removal)
- Snow Removal \$2,150
- Mailbox Purchase and Phase 1 Installation \$6,416
- Insurance \$2,392
- Legal \$2,579
- Operating (PO Box, postage & supplies) \$594
- Storm water fees to the City (New Fee) \$68
- Engineering/Design Storm Drain Relocation \$5,760

#### DUES INCREASE

Major Neighborhood Improvement Needs \*\$58,000 Storm Drain Relocation 2019 (Construction, permitting, and easement acquisition) \*Phased Fence replacement ~\$65,000 2020-2021 \*Re-build reserves





Regular Revenue 82 x \$325 = \$26,650 vs. Dues Increase Revenue \$395 = \$32,390 (+\$5,740)

## 2019 Proposed Budget Jill Mohler update

#### 1) Inventory Assets

- Fence
- Driveway
- Xeriscape areas
- Drain
- Mailboxes

2) Estimate Life Expectancy and Replacement Costs with interest

3) Develop a savings plan (reserves) to begin saving incrementally to replace and maintain assets. Volunteers needed for Reserve Committee

#### 3-6 months

Research costs, develop Reserve Strategy Report with amortized replacement costs
