Board Meeting Minutes June 25, 2019

# Treasurer Report:

HOA insurance policy has been paid. We were over-budget for snow removal and summer clean-up of common areas and rockscape. Five homeowners are delinquent in paying annual dues for 2018 and two for 2018 dues. Jill will check with HOA attorney on penalties for these homeowners. Current HOA closing balance is \$66,115. ACTION: Jill

#### Yard Sale:

Celeste reported that neighborhood yard sale was a success. Next year we will have homeowners RSVP for participation so we know where to place sale signs.

# **HOA Fencing:**

- -New claim has been submitted to insurer for damage for August 6, 2018, hail storm; waiting for adjustment of \$20,000.
- -We have a bid for \$45,000 for replacement of all fencing in timber treated wood and \$64,000 for cedar wood. Plan is to do replacement in two phases.

# Mailbox Replacement:

# Clean-Up:

The common areas and rockscape were cleaned and trimmed on June 21. The clean-up will be 2 times per year. Bills for weed trimming of Jessana Heights rear lots will be sent out to property owners ASAP. ACTION: Jill

# **HOA Drainage Project:**

The drainage project for mitigation of water run-off from HOA owned driveway will be July 15-17, 2019. The cost of the project is \$45,000, and will be accomplished by Sunland Asphalt; it will replace concrete curbing, two driveways and the surface asphalt. ACTION: Steve and Vince

# Damaged Curb Repairs:

Repair of the damaged curbing of the Langley and Broadmoor Bluffs islands will be requested from the City this year for 2020 scheduling. A 50/50 cost share with the City is required for these repairs to be accomplished. ACTION: Vince
